Dear Madam Secretary:

The Alliance of Community Health Plans (ACHP) recognizes that some dependent adult children may lose eligibility for health coverage on their family's policy – due to a change in student status, age, or other reasons – only to be reinstated after September 23 of this year under a provision of the Patient Protection and Affordable Care Act. The new law requires that dependent adult children who do not have coverage from their own employer may stay on a family policy to their 26th birthday. In the spirit of facilitating implementation of coverage extensions under PPACA, ACHP member organizations listed below will take steps to avoid this interruption in coverage by allowing currently eligible dependents to remain on their parents' individual policies in the period before the law's effective date and will work with employer groups to determine how their employees can also benefit from the coverage extension.

ACHP members are non-profit, community-based and regional health plans or subsidiaries of non-profit health systems that provide coverage and care for approximately 18 million Americans and 15 percent of Medicare Advantage enrollees. These health plans focus on improving the health of the communities they serve and are on the leading edge of patient care coordination, primary care innovation, accountable health care delivery, use of information technology and other innovations leading to improvements in affordability and the quality of care.

Thank you for your leadership on health care reform and on the issue of coverage for dependent children. We look forward to working with you to implement health care reform in a way that will promote delivery system reforms.
